The Form 5500 annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your Plan is a Single-Employer Plan defined contribution plan, which include the following characteristic(s) of 401(k),401(m),Automatic Enrollment,Default Investment Account,Directed Brokerage Accounts,ERISA Section 404(c),Group-based Non-Elective,Member of Controlled Group,Participant-Directed,Profit-Sharing.

## **Basic Financial Statement**

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$59,728,095. These expenses included \$636,134 in administrative expenses and \$59,049,989 in benefits paid to participants and beneficiaries and \$41,972 in other expenses. A total of 7295 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$844,077,786, as of December 31, 2023 compared to \$700,106,351 as of January 01, 2023. During the plan year, the plan experienced an increase in its net assets of \$143,971,435. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$203,699,530, including employer contributions of \$26,442,191, employee contributions of \$46,940,046 gains of \$0 from the sale of assets, and earnings from investments of \$123,072,738.
