

SUMMARY ANNUAL REPORT

For Group Insurance Plan for Salem Health Hospitals and Clinics

This is a summary of the annual report of the Group Insurance Plan for Salem Health Hospitals and Clinics, EIN 93-0823471, Plan No. 501, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Salem Health Hospitals & Clinics has committed itself to pay certain self-insured Medical, and Dental claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Modern Health Arizona, PLLC, Vision Service Plan, and Standard Insurance Company to pay Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$6,909,419.

Because the Standard Insurance Company are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2024, the premiums paid under such "experience-rated" contracts were \$5,215,490 and the total of all benefit claims paid under these contracts during the plan year was \$6,065,673.
